INTEREST GROUPS

THLA SUBCOMMITTEE ON THE UNION LIST OF PERIODICALS

Before the Subcommittee's recommendations are considered, there are several "pre-recommendations" we suggest that would facilitate the carrying out of these recommendations:

- A) Appointment of a Public Relations Officer
 - would be responsible for drafting a brochure highlighting THLA's achievements, particularly the Union List of Periodicals
- B) Appointment of a Membership Officer
 - would be responsible for an annual membership drive, as well as recruiting potential members throughout the year

Recommendations:

- 1) Future editions
 - that there be a 6th ed. in printed and disk form

Comment: even though the Consortium which is in the process of being established has a union list of periodicals as one of its highest priorities, this could take some time to get, going

2) Frequency

- annual publication

Comment: in the union list survey, the majority of respondents would like to see this as an annual publication. To aid currency, the THLA Newsletter could be used to report new titles and cancellations (if a library had substantial changes, library staff could send an appropriate number of copies to the newsletter editor)

- 3) Labour
 - Permanent Committee of three: Chair and two others (for terms to be determined)
 - Co-ordinator specified term (minimum two years, renewable)
 - Editor specified term (minimum two years, renewable)

Comment: We recommend forming an ongoing Union List Committee, hiring an Editor (contract position) who is on this committee and reports to the THLA Executive, and a Co-ordinator who links with the Union List Committee, contributors and Consortium (the latter if we decide to keep publishing our own union list). Both the Editor and Co-ordinator would need job descriptions.

- Committee responsible for developing policy and annual objectives
 - responsible for production of Union List
 - responsible for drafting policy and procedures manual
 - oversees quality control of type and number of Union List contributors; fills subject gaps in list (i.e. subject areas not already represented)
 - responsible for setting up mechanism for sale of Union List
 - initiates other projects (surveys, etc.) as needed

Editor - responsible for verifying journal information
- " inputting data
- " proofreading

Co-ordinator - aids the Committee in developing policy and annual objectives

- liaison with Committee, Editor, THLA Executive and Consortium

- responsible for contributor compliance (i.e. reporting of data in prescribed manner by contributors); Co-ordinator may have to offer individualized help sessions and/or general workshops
- responsible for final format of data
- 4) Obligations of contributors
 - procedures for reporting data must be built into ongoing library routine (there is no "good" time for all contributors to report, therefore, they must keep their lists up-to-date)
 - must be prepared to report their holdings at <u>any</u> time on demand
- 5) Procedure for submission and production
 - formalized procedures set out in a policy and procedure manual

Comment: this is imperative, as lack of standardized procedures (or non-adherence to the guidelines for submission of data) has contributed to lengthy delays in producing the Union List in the past.

6) Dual cost structure for 6th ed.

- members: \$50

- non-members: \$70

Comment: In the survey on the union list, about 33 members were willing to pay \$40-50, 19 chose \$50-60 and only 7 were willing to pay over \$60.

It would be best to keep this at \$50, even if the cost had to be subsidized by a slight dues increase.

- Suggested additions for union list
 - a) Inclusion of introduction
 - cut-off date for material
 - scope of union list
 - mention of other useful sources (govt. library lists, SLA directory, CISTI list, U of T Science/Medicine list, FELIX, YORKLINE, etc.)
 - b) Expanded library policies section
 - separate column for policies
 - FAX & Envoy numbers
 - subject section at end of library policies section (Committee should draft subject list for contributors to check off)
 - hospital specialities, strengths of library collection
 - c) Miscellaneous
 - use of a Canadian library symbol issued by the National Library
 - inclusion of change of address and feedback forms as part of union list
